**Minutes of the meeting of the Expert Committee held on 30/7/2019 at 14:00 hours in Conference Room, Sinchai Bhawan, Patna on identification of posts in Group B and Group C in GFCC, Patna under Ministry of Jal Shakti suitable to be filled up from new categories of disabilities mentioned in RPWD Act 2016**

A meeting of the committee constituted for identifying the posts in Group 'B'(Non-Gazetted) and Group 'C' cadre in GFCC to be filled up from among the new categories of disabilities mentioned in RPwD Act, 2016 was held on 30<sup>th</sup> July, 2019 at 14:00 hours in Conference Room ,Sinchai Bhawan, Patna under the chairmanship of Member(P) with Director(MP-1), Dir(MP-2), DD(HRM) & Administrative officer, for Empowerment of persons with Disabilities as its members

2. The GFCC, Patna is recruiting against the following posts of Group "B" (Non-Gazetted) and Group "C" posts in MoWR, RD&GR Deptt General and Stenographers cadre, Head Clerk ,LDC and Multi-Tasking Staff through Staff Selection Commission under Direct Recruitment Quota

3. The Committee was informed that the post of Head Clerk is a Group B(Non-Gazetted) post .Head Clerks are required to scrutinize and initiate financial and administrative proposals which requires analytical abilities and application of mind. Further, Head Clerks are the main source of recruitment into the GFCC General Cadre. As regards, the post of Stenographer Gr-1 is also a Group B(Non-Gazetted) post; the Committee noted that as per existing rules, recruitment to this grade is through a combination of direct recruitment or by promotion from Stenographer Gr-II. Stenographer Grade- II is the feeder cadre for this post. Recruitment of Draftsman post will done after revision of Recruitment Rule.

4. The Committee deliberated on the physical requirement and functional classification of these above posts and it was of the view that all the above posts except the post of Draftsman could be


identified suitable for all category of Divyangjan covered under Section 34(1) of the RPwD Act, 2016 except deaf-blindness. Post wise identification as recommended by the Committee is as under:-
